MISSION STATEMENT

Truth Christian Academy is operated by the Church of God (Universal), 12018 Point Salem Road, Hagerstown, MD 21740. It exists to assist parents and guardians in providing a quality education for their children from a Biblical perspective. Because of the importance of eternal values, our first aim is to build into the lives of all our students the principles and teachings of the Lord Jesus Christ. In addition, our aim is to prepare our students by academic instruction to take their place in the modern world.

ENROLLMENT

1. An enrollment application is to be completed for students entering Truth Christian Academy.
2. When a new student is enrolled, a copy of his birth certificate and his social security number need to be brought to the office. We will request school and immunization records for students transferring from another school.
3. Children are eligible for Pre-Kindergarten if they are 4 years old by September 30. They are eligible for the kindergarten class if they are five years old by September 30. Exceptions may be made if evaluations show that a child (born October-December) is ready for kindergarten work.
4. Students entering Truth Christian Academy in grades 2 and up will be administered an achievement test so that each may be placed with the group of students with whom he can work most effectively.
5. Upon enrollment students will pay the first month's tuition and a book fee (\$70 Pre-K-Grade 8; \$90 Grades 9-12).

ATTENDANCE

1. The 2022-2023 school year begins September 6 and ends May 25.
2. Fridays are considered homeschool days. Students are expected to bring back completed work the following Monday.
3. In case of bad weather, check your4state.com or local radio stations WHAG or WJEJ.
4. The following are legal excuses for absence:
 - a. student illness
 - b. inclement weather
 - c. death in the immediate family
5. Students who have been absent must bring a note signed by their parent or guardian giving the reason for the absence the day they return to school.
6. Educational trips are subject to school approval. A request should be made to the school one week in advance of the trip.
7. All absences after the 10th must be made up after school and on Fridays.
8.
 - a. No student may leave the school grounds before the close of the school day without permission from the office.
 - b. Students may not recover a ball off school property without permission.
 - c. Students who need to leave school before 3:30 should bring a note signed by a parent/guardian for the early dismissal. Parents coming to the school to pick up their children early without a note should come to the office to check them out.

TARDINESS

1. School begins at 8:30 A.M. and classes are dismissed at 3:30. Students are to be dropped off at their classroom door unless they are late, in which case they must enter through the front doors and get a tardy slip from the office.
2. A student arriving after 10:00 is counted absent one-half day and must bring a signed note for the absence.
3. Attendance by 8:30 with dismissal after 2:00 constitutes a full day.
6. After 10 tardy days, the student may lose free time at the teacher's discretion.

EARLY COMERS AND LATE GOERS

1. Doors will open for students at 8:15 in the morning. Students who are on the property before that time will not be supervised.
2. Students should be picked up within 15 minutes of the close of the school day and should remain in the designated room until their ride comes.

LUNCH

1. All lunch items must be ordered in the morning and are to be eaten in the classroom.
2. Students who need to spend their lunch time working should be in their rooms before the 12:20 bell rings.

WORK

1. Students are required to do homework and to correct assignments. Late or unfinished work should be completed during recess and lunch hour, and students who do not finish during this time may have to stay after school until 4:00 that day.
2. It is the responsibility of the student to see his teachers for work missed during absences. In case of a planned absence, the student should see the teacher for his work before the absence occurs.

PLAY

1. The Golden Rule is to be obeyed at all times.
2. Students are not allowed to fight or wrestle.
3. Students should not make or throw snowballs.
4. Students should talk quietly in the hallways during and after recesses and lunch break.
5. Students are not to get on the roof to recover balls or other items. A report should be made to the office so that items may be recovered.
6. On rainy days students in grades 1-4 may play in the basement from 12:15 until 12:30. Grades 5 and up may play from 12:30 until 12:45.

RESPECT

1. Students must be respectful to all adults, and especially to teachers. They must speak in a courteous manner to both adults and children.
2. Kindness is required. Older students should be especially considerate of the younger ones.
3. All school property is to be used with proper care and respect.

MISCELLANEOUS

1. Please stop by the office to leave a message or drop off items.
2. There is to be no chewing gum by students through grade 8.
3. In case of a fire drill, everyone should leave quietly and quickly (without running) by the nearest outside exit. In the case the nearest exit is blocked, exit should be made by the next closest exit.
4. There is to be no running in the hallways.
5. Students may not have matches, weapons, or anything that resembles a weapon at school.
6. Students are not to go into unused classrooms when no teacher is present, unless permission is given. Students are not allowed in a classroom other than their own unless the teacher for that class is present.
7. The school will not assume responsibility for personal items, such as toys, brought to school by students.
8. Students are not to climb on or over fences.
9. God's name is not to be taken in vain. A child who persists in using foul or vulgar language/gestures will be dismissed from the school.
10. Cell phones may be brought to school but must be turned in to the teacher by the beginning of class.

DISCIPLINE

1. The purpose of discipline in the school is to encourage and correct students in an effort to lead them into maturity and self-discipline.
2. Discipline at Truth Christian Academy has the following objectives:
 - a. To develop Christian character
 - b. To train students to conduct themselves in a manner that will help them to develop them into productive, well-adjusted adults
 - c. To maintain a good environment for learning
 - d. To correct the behavior of students whose actions are disruptive to the learning environment
3. Students who have been given detention will stay after school on the day designated by the teacher.
4. As a last resort, recalcitrant students will be dismissed from the school. Preliminary actions will include a conference with the parent and suspension.

PARENTS AND TEACHERS

Parents are encouraged to contact teachers when problems arise. Parents may feel free to visit classes during the school day, but they should stop at the office before going to their child's classroom.

PROMOTION

1. At the end of the school year, an achievement test is administered to students in Grades K-12. Achievement test results are used to determine growth during the year. The results of the achievement tests will be made available to parents.
2. If a student's work is borderline, he/she may be promoted on trial. His/Her work in the new grade determines whether he/she remains in the higher grade or is returned to the former grade.
3. Report cards are held at the end of the school year for those students who do not have a clear record (money, books, or absence notes not turned in).

DRESS CODE

Please note that this is not a statement about modesty. It is, however, the dress code, and as such must be adhered to.

GIRLS

1. Skirts for girls may not be too tight and must cover the knees when seated or standing. Girls may wear leggings/pants under their skirts.
2. Slits in the skirts must not extend higher than the bottom of the knee.
3. Shirts must be of a modest fit without offensive pictures or words.
4. Girls may not wear cap sleeves.

GIRLS 7-12

1. Students may wear t-shirts with the TCA logo. Other t-shirts may be worn under another garment and must not be too low, too tight, or too short.
2. Shirts for girls must have a collar and/or buttons with no offensive words or pictures.

BOYS

1. Boys must wear ankle-length pants that fit well.
2. Boys' haircuts must be kept at a conservative length.
3. Shirts must not have offensive words or pictures on them.

BOYS 7-12

1. Shirts for boys in grades 7-12 must have a collar and/or buttons with no offensive words or pictures.
2. Boys may wear t-shirts with the TCA logo; other t-shirts may be worn under another garment.
3. Acceptable colors for pants are khaki, navy, brown, gray, and other earth tone colors.
4. Boys may not wear sweatpants.

GENERAL

1. These rules apply during regular school hours, summer school days, field trips, and school programs. We would also like for parent volunteers to respect these standards when they are assisting.
2. Students are not permitted to wear makeup, nail polish, or jewelry.
3. Children should wear shoes that are appropriate for play.
4. Book bags, lunchboxes, etc. must not have offensive pictures or writing on them.

TUITION

1. Tuition is \$300/month for 9 months (September – May). Tuition may be higher for students with an IEP.
2. Tuition payments are to be made on or before the 5th of each month (except June, July, and August). The first payment for the school year is due September 5. A 10% discount will be given if the year's tuition is paid by September 30.
3. The State of Maryland is paying approximately \$90 per student for the 2021-22 school year for the purchase of library books, text books, and classroom materials.
4. There is a book fee of \$90 for high school students and \$70 for all other students.
5. All back tuition and fees must be paid before the student is put on the roll for next year.

BOOST SCHOLARSHIP PROGRAM

1. Truth Christian Academy participates in the BOOST Scholarship Program.
2. BOOST is a State of Maryland program devised to help lower-income students afford the K-12 education that best fits their needs. BOOST provides scholarships to eligible students to enable them to attend a nonpublic school. Maryland's BOOST Scholarship Program will provide nearly \$10 million in scholarships in the upcoming school year to eligible K-12 students toward tuition at a qualifying nonpublic school of their choice.
3. BOOST scholarships are available to public school students as well as current nonpublic school students who qualify.

AGREEMENT

We have read the **2022-2023** Truth Christian Academy policy and classroom rules and agree to abide by them. We understand the tuition policy and agree to make our tuition payments promptly. We have paid particular attention to the following:

- Any absence after the 10th must be made up after school and/or on Fridays.
- Planned absences (vacations) will be counted as part of the above 10 unless the student makes up the work **before** the absence.
- A student who has been absent must bring a note signed by his parent or guardian giving the reason for absence *the day he returns to school*.
- After 10 tardy days, the student may lose free time at the discretion of the teacher.
- The 2022-2023 school year begins on September 6 and ends May 25.
- Students will not be put on the roll for 2022-2023 until back tuition and fees are paid.
- A book fee of \$90 for high school students and \$70 for other students is due by June 5 for current students and upon enrollment for new students.
- Tuition is \$300/month for 9 months (September – May).
